Expected to develop the study design, purchase needed equipment and supplies, coordinate collaborating researchers, design and make specialized fixtures for biomechanical testing, implement biomechanical motion analysis testing involved in the Orthopaedics laboratories, Human Dynamics Lab, Comparative Orthopaedics and Biomechanical Lab (COB Lab), and the UF Health Sports Performance Center. Responsible for developing all computer programs to enhance data collection and analyses for all motion analysis studied. Provide project management and oversight for graduate-level research projects conducted by residents and fellows in the Department of Orthopaedics and Rehabilitation. Conduct, analyze, and prepare research papers from the data collected. Serve in a departmental consultative capacity for faculty and residents engaged in

biomechanics of motion analysis studies programs.
